The candidates are required to bring all their original marksheets and certificates including the original disability certificate issued by the Competent Authority. The candidates must produce their original matriculation certificate for verification of date of birth, Degree in Law from a recognised Board/Institute with 3 years standing as a pleader at Bar / certificate of 5 yrs service in any branch of Railway administration for serving Railway employees on the day of verification without fail. If any of the above candidates does not receive the call letter, the candidate may check the Railway Recruitment Board's notice board/website and attend the document verification strictly on the specified date indicated along with all documents.

The candidates belonging to SC/ST & OBC should bring their original caste certificate in prescribed format. In case of OBC candidates the caste certificate should be current and not more than one year old and should have clause of Non-Creamy Layer.

Candidates should bring their original call letters of Written Examination and Interview/Document Verification. The Candidates should also bring photocopies of all the original certificates and documents including the original disability certificate issued by the Competent Authority for Document Verification. Any candidate coming for the verification without complete documents will be asked to return and their candidature shall be liable to be cancelled.

Merely calling the candidates for document verification will not confer on them the right for employment in any Zonal Railway/Railway Organisation.
