The candidates are advised to attend as per the schedule given above without fail. The candidates coming late may lose their chance to attend the Typing Test. More number of candidates have been called for Typing Test so as to ensure sufficient candidate is available after typing skill test. The candidates have the option to do the Typing Skill Test either on Manual Typewriter or Personal Computers. If a candidate choose to do the Typing Skill Test on Manual Typewriter then the candidate have to bring their own Type Writer (Key Punching Type) along with them. The Manual Typewriter can be either of English or Hindi Type Writer as per their language choice for the Typing Test. Electronic Typewriter machines are strictly not allowed for Typing skill Test. Arranging of typewriter in time for the Typing Test will be the sole responsibility of the candidate. If typewriter brought by the candidate develops any snag or fails during the test then no extra time or alternative arrangement, whatsoever, shall not be made by RRB. So far as Typing on Personal Computers are concerned RRB will arrange Personal Computers for taking Typing Skill Test.

The minimum qualification in Typing proficiency will be @ 30 words per minute in English or @ 25 words per minute in Hindi for the typing test to be conducted on both Manual Typewriters and Personal Computers. In case the typewriting skill are tested in Personal Computers with the use of editing tools for correcting the mistakes the minimum qualification typing proficiency will be either @ 40 words per minute in English or @ 35 words per minute in Hindi. The Typing Test will be qualifying in nature for selection of these categories and attendance in Typing Test is compulsory. Five percent mistakes of the total words typed will be ignored and thereafter for every mistake corresponding words will be deducted from the total words typed for arriving at the speed.

The canidates are also advised that Physically Handicapped candidates are exempted from Typing Skill Test if they are found otherwise qualified and are certified as being unable to type by the Medical Board attached to the special Employment Exchange or by Civil Surgeon where such Board does not exist.

For the Typing Test Candidate should bring their original typing test Call letter without fail. Candidates should also bring their original call letter of First Stage & Second Stage Written Examinations. Any candidate coming for the Typing Test without call letters will be asked to return and their candidature shall be liable to be cancelled. If any of the above candidates does not receive the call letter, the candidate may check the result at the Railway Recruitment Board's notice board/website and also published in Emploument News/Rozgar Samachar and attend the Typing Test strictly on the specified date indicated above.

The candidates are required to bring all their original marksheets and certificates including the original disability certificate issued by the Competent Authority. The candidates must produce their original matriculation certificate for verification of date of birth , Disability certificate and Degree marksheet & certificate from a recognised University on the day of verification without fail.

The candidates belonging to SC/ST & OBC should bring their original caste certificate in prescribed format. In case of OBC candidates the caste certificate should be current and not more than one year old and should have clause of Non-Creamy Layer.

Merely calling the candidates for Typing Test will not confer on them the right for employment in any Zonal Railway/Railway Organisation.

While every care has been taken in preparing the result, the Railway Recruitment Board reserves the right to rectify errors and omissions if any.

IMPORTANT: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerized and selection is based purely on the merit of candidates.
